



Filling Your Dexcom G6 CGM System Prescription at the Pharmacy

We've put together a few tips to help ensure a seamless experience in getting your Dexcom G6 Continuous Glucose Monitoring (CGM) System prescription filled.

- ✓ **Electronic prescription:** You'll be able to pick up your Dexcom G6 at the pharmacy where the prescription was sent one to two business days after it was ordered.
- ✓ **Written prescription:** Take it to your pharmacy to fill. Your Dexcom G6 should be available to pick up one to two business days after you drop off your prescription.
- ✓ **Pharmacist information:** Share the information on the reverse side when you drop off or pick up your prescription.
- ✓ **Future CGM refills:** Visit the same pharmacy where you filled your first Dexcom G6 prescription.
- ✓ **Activate special offer:** See information below.
